

It's almost time for Sage certified consultants to renew their Sage certifications for 2021!

This renewal applies to certified consultants who hold competency roles for one or more of the following Sage products. Please see the table below for the fee title, recertification information, renewal fee and the number of support cases awarded for each paid renewal fee.

Renewal Timeline

- November 1, 2020 A renewal fee notification email will be sent to all certified consultants
- November 30, 2020 Renewal fees are due
- November 30, 2020 Support cases expire. (2018 support cases will be awarded on 12/1/2020 or upon payment of 2021 renewal fee, whichever is later.)
- December 31, 2020 Grace period ends and a late fee of \$200 is assessed
- February 1, 2021 Consultant's certification expires if renewal fee(s) is not paid



Key Renewal Information

- Certified consultants can view their current certification(s) from their Sage University transcript
- The applicable 2021 renewal fee(s) will be placed on the consultant's Sage University transcript on November 1, 2020. Fees are based on competency roles held as of October 1, 2020
- Business partners that have designated a consultant manager can utilize the Sage University My Team
 functionality to verify their organization's consultant list and renewal fee status. Please notify us

 about the consultant manager program
- · Renewal fees can be paid by the consultant or by their consultant manager

Certification Maintenance (formerly known as recertification)

- Certification maintenance requirements commonly include training and assessments associated with a new release of the software
- For Sage X3, Sage added certification maintenance requirements during the program year and communicated the timeframe for consultants to complete requirements. Please see the above grid for details.
- Consultant certifications will expire if recertification requirements are not met

Consultant Managers

Consultant managers can manage the renewal process on behalf of a consultant by purchasing an inventory of renewal fees and assigning those fees to their consultants. For instructions on processing your organization's certified consultant renewal fees, please use the job aids below.

Multi CC Discount

Business partners paying for 6 or more certified consultant renewal fees for consultants associated with their account ID are eligible for the following discounts:

Number of renewal fees:	Discount
6 to 10	20%
11 and more	30%



Key Renewal Fee Discount Information

- Discounts are based on the number of renewal fees per Sage account ID (4XXXXXXXX).
- Discounts will expire on the renewal fee due date 11/30/2020 at 11:30 PM ET.
- Discount percentage is based on the number of renewal fees on October 1, 2020 that each Sage account number is responsible to pay by the renewal fee due date.
- Discounts will be automatically applied to renewal fees at the time of check out regardless of who
 purchases the renewal fee(s); consultant manager or consultant.
- At the end of the renewal period, we will audit the number of renewals you processed to confirm you were entitled to the multi CC renewal fee discount. If for some reason you didn't renew the applicable number of consultants, we will send you an invoice for the balance due.
